Hi, Y'all,

Where to put the new bulbs that have come in? Did I REALLY order all these?! I know my gardens are getting full, but somehow I always find room for more daffodils. This is the time of year that I wonder "why", but in the Spring, I have the answer!

One question that we usually get from new members is how to label the daffs. I use a Brother Label Maker with laminated tape labels and put them on metal plant markers. I put the variety and code on the front and back of the marker. They have been good for at least 5 years.

Some folks use old blind slats, cut to about 8 inches and write on them with a wax pencil. Magic Markers or Sharpies will fade. You, also, need to put the name in the hole with the bulbs. I use old plastic milk cartons, cut into small pieces and write with a ballpoint (not gel) pen. Then make a map of the area!

We all like a good value!

NOW is an excellent time for you to save money on your ADS dues, by renewing for three years. ADS dues will increase, effective 1 July, 2013. ADS has not had a dues increase for individuals, family/households in 22 years.

When the dues increase on July 1 of **next year** the rates will become:

1 yr individual ...\$30
3 yr individual ...\$60
1 yr youth. ...\$10
1 yr family/household...\$35
3 yr family/household...\$90
Individual life...\$750

The **current** dues are:

1 yr. individual ...\$20
3 yr. individual...\$50
1 yr. youth...\$5
1 yr. family/household...\$25
3 yr. family/household...\$60
Individual life...\$500

Please check the back cover of your latest Journal for you dues paid thru date. If it doesn't say that you are paid thru SEP 2012, you are in arrears. We ask ADS members to align with our JUL 1 dues payment date, either paying annually or once every three years. How do you align with JUL 1?
