Cecile, our bulb chairman, received the following from Richard Havens, P. O. Box 218, Hubbard, Oregon 97023 (Formerly Grant Mitsch):

PRICES FOR GARDEN CLUBS

We have many requests for special prices for Garden Clubs and have been supplying group orders at discounts for some time. Inasmuch as we are specializing in new introductions, there are limited numbers of older varieties grown which may be of general interest to clubs. We try to accommodate group orders and make concessions in prices. To enable us to accomplish the preceding, we ask the adherence to the following rules when ordering.

- 1. Orders of \$100.00 to \$249.00 -- 20% discount; orders of \$250.00 or more are entitled to a 25% discount.
- 2. Collections, Seedling Mixes and net items offered in the catalogue are not discount items.
- 3. To be eligible for discounts, we ask that all orders be sent together at one time and by one person and made out as one order. For example, if 25 individuals were to order one bulb each of Allurement, the club order should be listed as calling for 25 Allurement, which will be placed in one sack, for dispersal by the garden club.
- 4. Order will be shipped to individual completing the order unless requested otherwise.

We encourage early orders, which will assure the greater availability of the requested varieties. The reduction of handling costs permits the offering of the discount. Thank you very much for your cooperation.

Bulk orders deadline is May 23 according to our program schedule.
